

- Grants must cover the whole of the project unless shared directly with the applicant.
- 3) Grants are paid directly to the successful applicant by Woodmansterne Publications Ltd on completion of the conservation work (the deadline for completed work being 1st December 2024), with such grant to be claimed by the applicant invoicing Woodmansterne Publications Ltd.
